Crating available:
Please use social distancing when crating. We will be marking out crating areas. Use of stakes 6" or smaller will be permitted.

Entry Limits:
350 runs per day

Move ups:
Move ups will be allowed for both Saturday and Sunday. Trial Secretary must be notified before the end of the trial each day

Day of show Entries:
Day of show entries for anyone will be allowed until 8 am each day. The secretary will accept entries for the following day throughout the trial.

Refunds:
No refunds for entries in the event a dog and/or handler are dismissed from competition, regardless of the reason for such a dismissal. A withdrawal from the trial after closing date due to bitches in season, an injury and/or illness to the dog or handler will be eligible for a refund up to 75% of your cash and all scrip. A veterinarian's or doctor's notice will be required for a refund. If you feel you have circumstances that require a refund that are not due to the above stated reasons, please email the show secretary and your case will be reviewed after the trial. No refunds will be refunded if the trial cannot open or be completed by any cause beyond the control of the organizing committee.

JUMP HEIGHTS

There are four Standard Division-Proficient jump heights: 8", 12", 16", and 20".

There are four Standard Division-Skilled jump heights: 4", 8", 12", and 16".

There are four jump heights for the Veterans and Junior Handler divisions: 4", 8", 12", and 16".

Brief Summary of Rules:

Please refer to www.nadac.com for a full explanation of all NADAC rules and up to date information.

- Please note that NADAC trials should provide a safe and fun environment for both exhibitors and their dogs.
- Aggressive dogs will not be tolerated and will be excused from the trial.
- The show committee has the right to refuse any entry. Anyone not currently in good standing with NADAC will not be allowed to enter this trial.
- Exhibitors, through submission of entry, acknowledge that they are knowledgeable of NADAC rules and regulations, and agree to abide by all rules in effect at the time of this trial.
- No entry fee will be refunded if the trial cannot open or be completed by reasons of riots, civil disturbances, fire, acts of God, public emergency, an act of a public enemy, or any other cause beyond the control of the organizing committee.
- Checks not honored by the bank do not constitute a valid entry fee. There will be a \$25.00 service charge for bank returned checks.
- Dog must be registered and have a valid registration number before entries will be accepted. <https://www.nadac.com/register-your-dog/>
- A copy of the current Exhibitors Handbook may be downloaded free from the NADAC web site: www.nadac.com
- Bitches in heat, lame, or blind dogs are ineligible for entry, as is any dog with a deformity which may cause a judge to not be able to reasonably assess the dog's ability to function and perform agility obstacles safely, and in a manner that is in the best interest, health and welfare of the dog.
- No food, clickers, or other aids or devices shall be permitted on the course or within 10 feet of the ring. Food or a small non-audible toy can be in a secure container (ziplock bag is acceptable) in your pocket during your run but it cannot be used during your run, nor can you indicate to the dog it is there. All Handlers may bring a non-audible toy into the ring for training purposes. They cannot earn a Qualifying score and must declare to the judge they are training before they commence their run. Please read the Exhibitor's Handbook for more information about toys and training in the ring.
- The sponsoring clubs will not be responsible for the loss or damage to any dog exhibited, or for the possessions of any exhibitor whether the result be accident or other cause. It is distinctly understood that every dog at this event is in the care and control of his owner or handler during the entire time the dog is on the show premises.

AGREEMENT

The person who signs this agreement represents that he/she is authorized to enter into this agreement on behalf of both exhibitor and the owner of entered dog. In consideration of acceptance of this entry:

1.1. As used here "NADAC" means the North American Dog Agility Council, LLC., its members, officers, directors, employees, show chairs, show committees and agents.

1.2. Exhibitor/owner agree to abide by the rules and regulations of NADAC and any other rules and regulations appearing in the premium for this event.

1.3. Exhibitor/owner certify that the entered dog is not a hazard to persons, dogs or property and that the entered dog's rabies vaccination is current in accordance with the requirement of the state in which the dog resides.

1.4. Exhibitor/owner acknowledge all hazards presented by the event and the event premises, including, but not limited to, the condition of the surface, restrooms, security measures or lack of, electrical appliances, fittings, show rings, parking areas and the presence of unfamiliar animals and people; exhibitor and owner assume the risk of any harm arising from these.

1.5. Exhibitor/owner releases NADAC (including its respective officers, directors, employees, and Members, Saguaro Scramblers (including its officers, directors, members, and event organizing committee), and Kino Sportsplex (including its officers, agents, and employees) and will defend them and hold them harmless from all present and future loss, injury, damage, claims, demands and liabilities involving the entered dog, the event or event premises. Without limiting the generality of the foregoing hold harmless provisions, exhibitor/owner hereby specifically assumes sole responsibility for and agrees to indemnify and save the aforementioned parties harmless from any and all loss and expenses (including legal fees) by reason of the liability imposed by law upon any of the aforementioned parties for damages because of bodily injuries, including death, at any time in consequence of my (our) participation in this event, howsoever such injury or death may be caused and whether or not the same may have been caused or may have been alleged to have been caused by negligence of the aforementioned parties or any of their employees or agents or any other persons

Measuring: Starting January of 2025, NADAC will be requiring all dogs to have a permanent height card. All dogs will be required to have a permanent height card on file -This includes both Skilled and Proficient. Dogs who are “way” under may send in the form with only one judge signature marking that they are way under. Dogs who are **clearly** over 18”, visually verified by a Judge, and measure into the 20” Proficient Height are **not** required to have a permanent height card. A picture of the height card form can be taken and emailed to support@nadac.com once it has been filled out and signed. Height cards from other venues are accepted. Containerized Trial

This will be a containerized trial: no one may leave treats or toys around loose, either at ringside or at their set up. You may carry treats in a container in your zippered pocket when you run. You may not indicate to the dog that you have them nor treat the dog until you are at least 10 feet from the ring.

CLASS CHANGES

If you wish to move your dog up to a higher class you must notify the trial secretary before 6 pm, December 9. Move-ups will be allowed from day to day at the trial within 30 minutes of the end of the class.

Day of Show Entry

Day of show entry will be allowed until 8 am each day. NO day of show entries will be accepted for the current day after 8:00 am unless prior approval by show secretary has been given. The secretary will accept entries for the following day throughout the trial. Day of show entries can be emailed the night before.
