Waiver of Liability and Informed Consent COVID-19 Waiver

I hereby agree to hold Saguaro Scramblers Dog Agility Club Inc., (hereinafter SSAC) its members, directors and officers, and Pima County (Arthur Pack Park) and/or City of Tucson (Reid Park) harmless from any claim for damage, loss, or injury, illness or death which may have been caused directly or indirectly to any person or by the act of any dog(s) in my custody while participating in any SSAC sponsored activity.

I attest that to the best of my knowledge, I do not have COVID-19 at the time of attending a SSAC sponsored event, and understand the risks of unknowing exposure to this and other illnesses by or to myself, my family, other participants, and third parties. I have not been tested and found positive; am not waiting for test results; and do not have COVID19 symptoms. I agree that I will not knowingly expose others to any illness I may have or be at risk to have. I will follow all SSAC rules and requirements to reduce any exposure and possibility of contracting or spreading the virus. I will also fully cooperate with and follow any City, County or State/Province guidelines that have jurisdiction in the area in which the event is taking place. If any of the above should change prior to my arrival at the event site or during the completion of the event that is the subject of this consent, I will inform SSAC and proceed accordingly in light of the new information.

I agree that I am attending a SSAC event entirely at my own risk and assume all risk and full responsibility for my own health, well-being, and safety during the event. I fully agree that SSAC, the owners/board members, employees, assistants and volunteers are in no way liable for any present or future COVID-19 exposure incurred at any time by any person, in attendance or not in attendance, during or after this event. I hereby waive and release SSAC, the owners/board members, employees, assistants, and volunteers from any and all liability for damages or personal injury to me, my dogs or my property.

Further, I hereby indemnify and hold harmless SSAC, the owners/board members, employees, assistants and volunteers from any and all claims by or liability to any third party arising out of my participation in the SSAC event. Any liability to anyone for any incident involving myself, the location, or those pets or actions of other participants and spectators will be my sole responsibility and I assume all financial liability and will also assume all and any financial costs associated with my actions.

Release for dog less than 15 months of age.

Dogs should be at least 15 months old due to growth plate development, attention and lack of obedience control. If the dog is less than 15 months of age, I will not hold Saguaro Scramblers Agility Club responsible for any injuries incurred or any future injuries resulting from jumping or obstacle execution at a young age as a result of using the club's agility equipment.
